





ACO Cost of Care Drill Down: Physician Part B MSSP ACO 2016 - YTD 2020 Q4






A sustained decrease in Physician Part B costs, mainly with Procedures, E&M codes and Laboratory.

■Long Term Hospital




An overall reduction of inpatient cost in 2020, primarily from a decrease in acute hospital utilization


